Ph.D., Political Science Examining Fields: <i>International Relations and Comparative Politics (Europe)</i> Dissertation: <i>Citizens, Residents, and Guest Workers: A Transatlantic Analysis of Immigrant Rights and Political Cleavages</i> Description: My dissertation examines the effect of migrant rights on the immigration policy-making process. It demonstrates that the political coalitions that form over questions of immigration vary as a function of the bundles of rights granted to a group of migrants. In so doing, it presents a theory of immigration policy making that is grounded in the political economy literature on the cross-border flows of factors and commodities but also accounts for the non-economic impact of migrants.
